HIGHLIGHTS OF THE YEAR

Programmatic Achievements:

- The Ackerman Clinic provided 4,000 family therapy sessions.
- More than 450 mental health professionals took part in the Ackerman training program and in one-day workshops.
- Ackerman faculty presented lectures and workshops in more than 15 states and internationally in Chile, Argentina, Canada and Great Britain.
- Ackerman faculty published numerous articles in professional journals.
- More than 150 professionals and students attended Ackerman's second annual one-day conference, featuring Celia Falicov, PhD, who spoke on *New Immigrants in Therapy: Transnational Journeys.*"
- Seventy international colleagues from Chile, Argentina, Israel and Japan came to Ackerman for special training sessions. Ackerman faculty also provided training in those countries.
- The Alumnae/i Association offered a diverse series of presentations attended by 167 alumnae/i and guests.
- Ackerman presented the Seventh Annual Carl Kempner Memorial Lecture, featuring Michael Davidovits, PhD, who spoke on *Of Hope and Loss: Immigration, Adolescent Depression and the Family.*
- With very generous support provided by the Robin Hood Foundation, the Center for the Developing Child continued to expand its Personal Best and Bright Beginnings Programs.

Institutional Achievements:

- Hosted the first annual Tribute to Families Gala, which raised more than \$700,000 in support of the Institute.
- Sponsored a highly successful theatre benefit, which netted approximately \$90,000 for the Institute.
- Redesigned and launched the Ackerman web site with a host of new features, including an Ackerman video, photo galleries, a news section, alumnae/i and faculty news pages and an events calendar.
- Redesigned the Ackerman newsletter and published a new Ackerman brochure.
- Hosted a Rusty Magee Clinic event, featuring opera singer Frances Ginsberg.

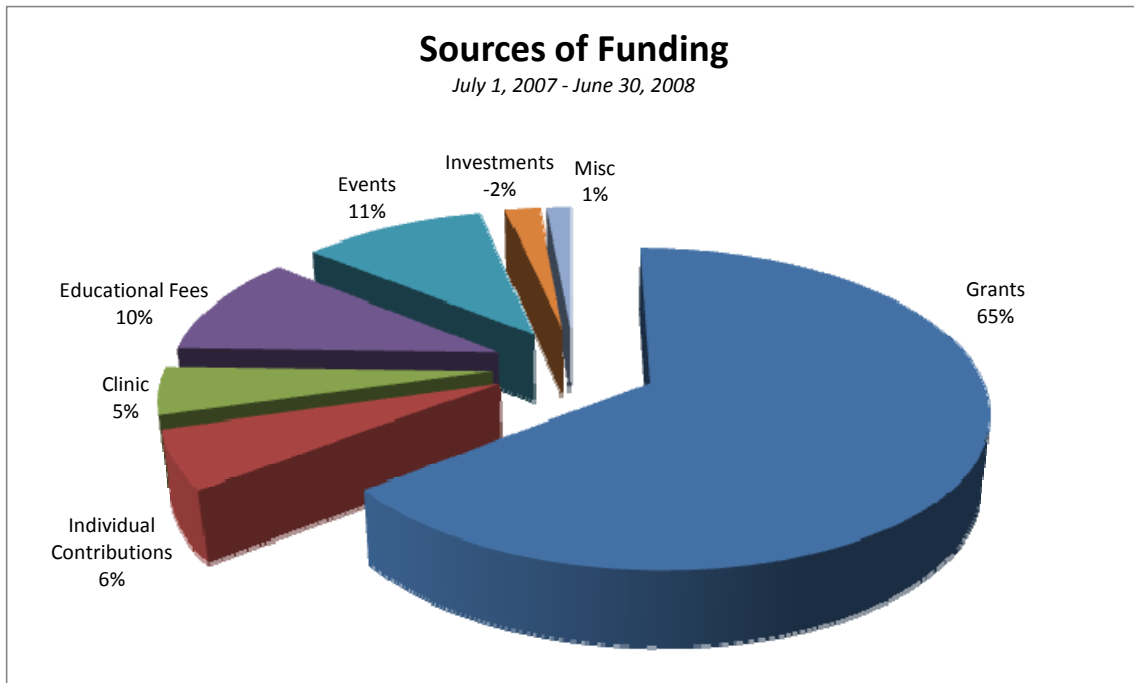
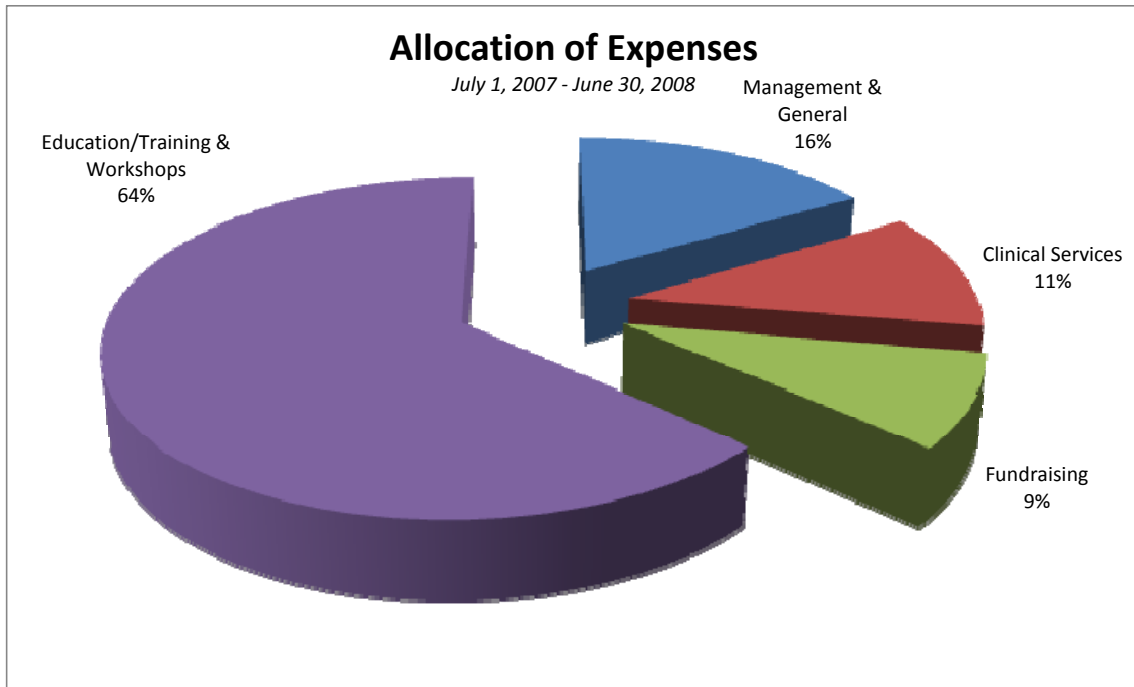
